3. How We Use Your Information

Premier Air, Inc. may use collected information to:

- Provide, operate, and maintain our website and aviation services
 - Respond to charter inquiries and service requests
 - Provide flight quotes and coordinate aircraft charter services
 - Manage reservations, travel arrangements, and customer accounts
 - Process payments and billing activities
 - Provide customer support
 - Send operational updates and account notifications
 - Send marketing communications, promotional offers, and service announcements when customers have provided appropriate consent
 - Improve our website, services, and customer experience
 - Maintain security and prevent fraud

These providers may only use information as necessary to perform services on our behalf.

We may disclose passenger information or personal identifiers when required by law or aviation regulations, including requests from government agencies such as:

- Federal Aviation Administration (FAA)
- Transportation Security Administration (TSA)
- Customs and Border Protection (CBP)

Business Transfers

If Premier Air, Inc. is involved in a merger, acquisition, financing, restructuring, or sale of assets, your information may be transferred as part of that transaction.

SMS Privacy Protection
